1) All series conducted under the rules and regulations of the Ohio State Racing Commission, the United States Trotting Association and Miami Valley Gaming & Racing, LLC. 2) Post positions in all legs drawn by lot. 3) At the time of declaration, with the exception of championship legs, a horse must meet current qualifying standards at MVR (official track variances allowed). 4) Declarations close in accordance with the current draw schedule at MVR. 5) Nomination fee must accompany all nominations. No starting fees required. 6) Nomination fees will be used toward the final purse. 7) MVR requires six separate betting interests in any event or it may be canceled. 8) In the event more than eleven enter any preliminary leg of Series 1-9, the race will be split into divisions. 9) Horses with the highest earnings in preliminary legs will qualify to compete in the final. The final will be limited to nine starters with no more than two declarations from any owner or trainer. In the event that any of the highest money winners fail to declare, series starters with the highest earnings may be drawn if declared, to fill. If two horses have tie earnings for the final spot, ten horses will be drawn to race. If more than two are tied, horses with two series starts will get preference. If a tie still exists random draw will determine the ten starters. 10) MVR reserves the right to reject any entry and return fee and declare off the event if sufficient nominations (at least 18) are not received. 11) In the event a horse is claimed during the series, all purse earnings accrued by a horse will count toward that horse's total for the final, regardless of the owner of a horse in a given leg. Each series may be limited to 40 nominations. If more than 40 are nominated, preference may be given to Ohio-sired, Ohio-owned and then Ohio-trained horses. 12) In every horse's first start in a series, it will carry a claiming tag of the advertised base claiming price for the series (plus normal allowances). 13) In a horse's second start in a series, it will carry a claiming tag that is 30% higher than the advertised base claiming price. 14) There is no claiming in the series finals.
